Recent Activities:

- A new fence was built along the east property line of the cemetery, however the old chain link fence has not yet been removed due to wet conditions. Plans are to remove the old fence once the ground dries out.

- The cemetery association property lines have been surveyed and marked and the mowing contractor has begun mowing the entire tract
- Billy Binford has been spraying herbicide on the fencelines and trapping the armadillos that have been digging in the cemetery. Billy has also been poisoning the ants that have been getting established around the cemetery.

Election of Director:

- Vote: Unanimously Affirmative to re-elect Bradley Fuqua to the board for a 5 year term ending 2026.

Election of Secretary:

- Vote: Unanimously Affirmative to elect Laurel Stout as secretary for a 2 year term ending at the annual meeting in 2023.

Vote to Approve Association Dues for 2021:

- Motion: Continue with \$50 dues for the next year – Laurel Stout, Seconded – Mike McLain
- Vote: Unanimously Affirmative
- Dues will remain at \$50 for the next year.

Vote on New Member Fees for 2021:

- Motion: New Member fees to remain at zero for 2021 – Melanie Rogers, Seconded – Billy Binford
- Vote: Unanimously Affirmative
- New Members fees for 2021 will remain at zero dollars.
