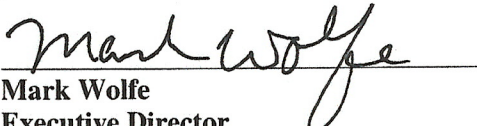
COUNTY OF GRIMES

That the Texas Historical Commission, an agency of the State of Texas, does hereby certify and declare:

That the Fuqua Family Cemetery, located in the E. Fuqua Survey, A-206, Grimes County, Texas and more particularly described in the corrected Exhibit A as attached hereto, has been set aside and dedicated for cemetery purposes through historic use and that such property is now occupied by human graves.

That this dedication is subject to all the laws, rules, and regulations of the State of Texas regarding cemeteries now in effect and to those adopted after the effective date of this dedication, and is made in accordance with 13 Tex. Admin. Code Section §22.6.

This corrected Affidavit of Dedication for Cemetery Purposes is signed and executed on this 7th day of December, 2021.

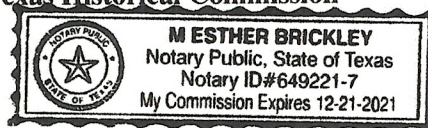

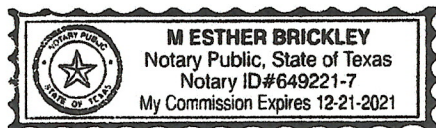

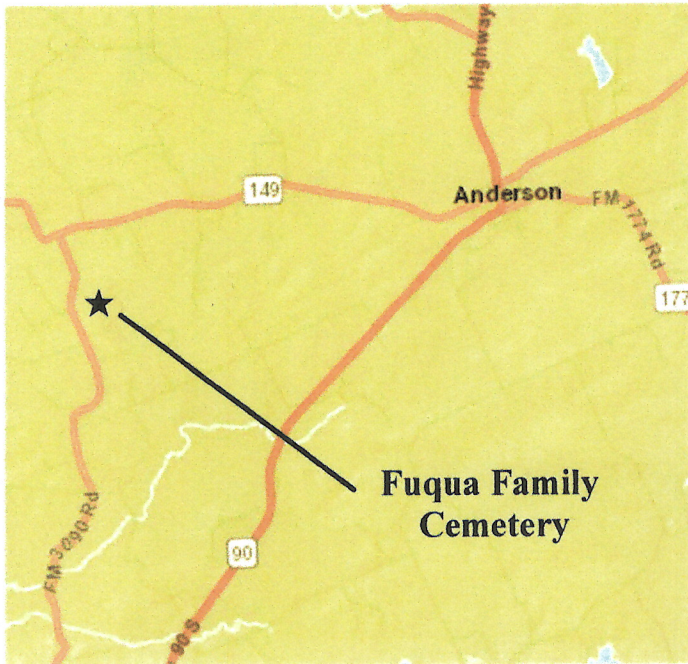

The original Exhibit A gave an incorrect measurement of the cemetery's eastern boundary.

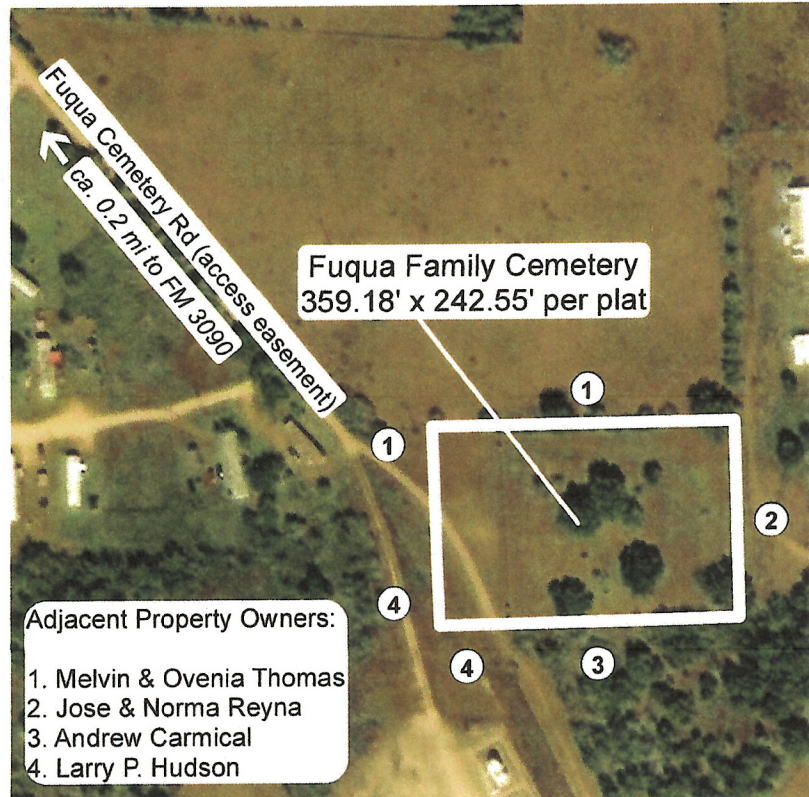

A 1931 deed (Vol. 123, p. 336) set aside "2 acres contained in the Erwin or Fuqua Prairie Cemetery," but gave no dimensions. No dimensions were recorded in the Official Public Records of Grimes County until the official plat of Scenic View Estates was recorded in 1990 (Vol. 651, p. 227). Refer to plat for all lot lines, dimensions, and easements.

Grimes CAD recognizes the 2-acre cemetery with Property ID R16557. Exact historic boundary of the cemetery is not known. Existing fence encloses less than 2 acres.

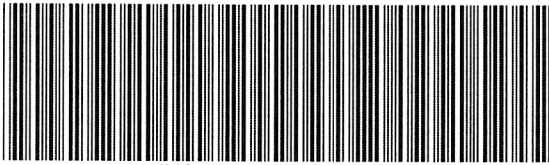
